


Highlights of Endowment Report and Recognitions

- Class Fund Update A total of \$270,835.29 given through 2,660 gifts from 439 donors. 35 classes are now eligible to make grants. Check out your Class Fund total at www.sjse.org/funds
- Building Bridges Maintenance Fund continues to grow and has now given a total of \$151,620 in maintenance support to the school since 2007.
- Total value available to St. Joseph School during the 2018/19 school year is \$352,720.
- Endowment Total Assets as of June 30, 2018 was \$8,022,260.11.
- Total given by the Endowment to the School \$2.5M+ in cash and \$2M+ in rent value (use of Elementary School and After School Program facility) for a total of \$4.5+M over the past 42 years.

WAYS TO LEAVE YOUR LEGACY AT ST. JOSEPH'S

ARE YOU 70½ YEARS OLD WITH AN IRA?



If you are age 70½ or older, you must now start taking distributions from your traditional IRA or Roth IRA. Why not help your favorite charity? St. Joseph School Endowment & Charitable Trust, St. Joseph School, and/

or St. Joseph Church are all eligible charities to receive those distributions that would otherwise be taxable income for you. These "qualified charitable distributions" are federal-income-tax-free to you. A qualified charitable distribution means a payment by your IRA trustee directly to a qualified public charity. The money cannot pass through your hands. This rule has been permanently put into the IRS laws. Should you have any questions, you may contact the Endowment office at 329-1818 or seek legal advice from your IRA trustee. Although you may make a contribution of any size up to \$100,000, why not think about creating a designated fund. What better way to leave your legacy! Or create a legacy for family members who are no longer with us but loved Catholic education.

Designated Funds

Donors may establish a designated endowed fund to aid certain departments or needs. The donor is required to make a contribution of \$10,000 within a 5-year pledge period and is then allowed to name the designated fund. A fund is eligible to make grants to St. Joseph School for its intended purpose one fiscal year after the fund is fully funded. What better way to leave your legacy!

The Dr. Phil & Jan Stone and Dr. Herd & Elizabeth Stone Endowed Fund for the Sciences




