Osmo makes hands-on learning games in which players use objects in the real world to interact with the digital world shown on their iPad. The Osmo allows the students to do the following: Coding, Math, Drawing, Spelling, Spatial relational skills. Osmo games foster social-emotional skills like problem-solving, creativity and perseverance. Every Osmo game requires the player to use reasoning to arrive at the correct answer, or even to chart a new path entirely.



# LEAVE YOUR LEGACY

#### **DESIGNATED FUNDS**



Donors may establish a designated endowed fund to aid certain departments or needs. The donor is required to make a contribution of \$10,000 within a 5-year pledge period and is then

allowed to name the designated fund. A fund is eligible to make grants to St. Joseph School for its intended purpose one fiscal year after the fund is fully funded. What better way to leave your legacy!

#### ARE YOU 701/2 YEARS OLD WITH AN IRA?








St. Joseph K-12th grades has current enrollment of 446. Pre K3 and Pre K4 enrollment is 76.




SJS social studies teacher Karen Davis was the winner of the Grand Prize drawing for the 107th Annual Bazaar. St. Joseph Bazaar netted


